For and In consideration of the sum above, I willing enter into this contract with Full Performance Marine (FPM), to provide storage for my boat for the period mentioned above. I herein understand and agree to the following rules and conditions:

**\*This contract is binding for as long as my boat remains on FPM property.**

**(Initial) \_\_\_\_\_ \*I understand I am responsible to maintain insurance coverage on my boat throughout the time my boat is in FPM storage. FPM does not accept any obligations for insurance coverage of my boat and property. Full Performance Marine is not responsible for customer's insurance deductibles. (Please leave a copy of your insurance binder for our records. Thank You)**

I will not hold FPM responsible for any damage to my boat, motor, equipment, etc. caused by fire, theft, burglary, wind, storm or any act of God. I agree that FPM it's agents or employees shall not be liable for any damage, loss, destruction of, or to, my boat or any article attached thereto, from any cause whatsoever. I further agree I will not hold FPM liable for any injuries sustained myself, members of my household, guests, agents, or employees, whether such injuries be due to negligence on the FPM property, it's agents or employees.

No outside contractors or individuals are permitted to work on my boat at FPM facility while in storage. I understand that if I cause any damage to any FPM storage building, (backing into the building, etc...), I am liable for the damages.

I understand that I am not permitted to advertise my boat for sell on FPM Property.

I understand if I remove my boat from storage prior to the termination date shown on this contract the (1) I forfeit my right to a storage space at FPM (2) I am not entitled to a refund of the storage fee.

Note: The fully enclosed winter storage building, once the boats are placed inside for the winter, they can't be moved until Spring.

All Storage bills must be paid the 1<sup>st</sup> of each month. Invoices will be sent monthly with a late charge on overdue amounts at the prevailing legal monthly rate.

Should my boat remain in storage past the expiration date of the contract I understand all excess storage time will be billed at the rate of \$ 10.00 per day.

I understand FPM retains the right, and option, to remove any boat from inside or under roof storage and be placed in outside storage for any bills overdue more then 30 days. I will not hold FPM responsible for any weather damage to my boat if placed in outside storage.

I give FPM the right to retain possession of my boat and associated equipment caused by any unpaid bills until such bills are paid in full with any late payment charges incurred.

I understand FPM may, at its option, institute such legal proceedings as may be necessary to collect any unpaid bills and that I will be responsible for reasonable attorney's fees and court costs in addition to unpaid charges. I give FPM my permission to sell my boat for payment of unpaid charges if the said charges remain unpaid for two years.
